Approval of the Agenda

Ms. Meyer moved to approve the agenda for the May 29, 2025, Board Meeting. Motion was seconded by Ms. Hagedon. Motion approved unanimously.

Public Comment (Public comment period is open and limited to two minutes)

Dr. Fertig and Dr. Wheeler discussed concerns the Iowa Veterinary Medical Association Veterinary Technician Committee has regarding the fee and the proctored exam for the Iowa Veterinary Technician State Examination. It was stated surrounding states do not have a jurisprudence exam and those that do have the exam it is an open book online exam, and the fee is \$50. The proctor agreement between American Association of Veterinary State Boards and the Iowa Board of Veterinary Medicine established the fee that is charged for proctoring the exam. The statement was made about why proctor the exam when other states have open book exams. Dr. Fertig stated the Veterinary Technician National Examination is being administered at DMACC. Mr. Larson will review the rules during the time when the Veterinary Technology Programs administered the Veterinary Technician State Examination and report back to the Board.

Approval of the Open Meeting Minutes

Ms. Meyer moved to approve the Open Meeting Minutes of April 24, 2025. Motion was seconded by Dr. Sato. Motion approved unanimously.

Financial Report

Dr. Kaisand reported the Board's financial status for FY25 with the current balance of \$227,063.36.

Executive Secretary Report

Dr. Kaisand reported the New World Screwworm is moving north from Mexico to the United States. The border is closed to cattle, bison, and horses moving into the United States through Veracruz which is the main passage from Mexico. Panama is releasing sterile male screwworm flies to mate with females is a common practice to help eradicate the disease.

Highly Pathogenic Avian Influenza (HPAI) was discussed. A large layer site tested positive in Arizona and a turkey site in South Dakota tested positive.

The legislature did not provide funding to the Iowa Department of Agriculture and Land Stewardship to pay veterinarians for Brucellosis vaccinations for cattle after June 30, 2025. The veterinarians need to know this so they can provide the information to producers who will then pay for the vaccinations.

The Power of Ten Committee stated the Iowa Board of Pharmacy (IBOP) is making inspections at veterinary clinics that store controlled substances. The IBOP is not targeting clinics but being more informative about out-of-date drugs and logging that information. The IBOP requires each veterinarian to have their own pharmacy license but only one Drug Enforcement Administration license is required in a clinic.

Chairperson Report

Dr. Burkgren reported that JBS is going to build a slaughter plant near Perry. The plant will be the largest sausage maker in the United States and will start employing 250 individuals and increase to 500 employees. The plant should be completed by September 2026.

Assistant Attorney General Report

No report.

Board Member Report

Dr. Sato reported the HPAI grant challenge was due last week. There were over 400 applications submitted.

Ms. Meyer stated the Humane Society of the United States (HSUS) reported the top 10 worst animal breeding facilities are in Iowa.

Correspondence

Ms. Anne Duffy contacted the Iowa Board of Veterinary Medicine about partnering with them to present to the students at Iowa State University College of Veterinary Medicine regarding licensing, Administrative Rules, and the Veterinary Practice Act on October 6, 2025. The Board staff will review their availability to partner with Ms. Duffy.

Petition for Waiver

Veterinary License/Veterinary Technician Registration Application(s)

Dr. Nilson Ribas Neto submitted the Application for License by Endorsement to Practice Veterinary Medicine. Dr. Ribas has a limited license to practice equine reproduction in Canada. Dr. Ribas has met the requirements by endorsement. Questions were asked of Mr. Larson regarding the Canadian license is limited would the Board be able to limit his scope of practice with a license by endorsement. Mr. Larson stated that the license by endorsement would be a full veterinary license and not limited to a specific area of veterinary medicine. There have been no complaints filed against Dr. Ribas during any of the temporary permit licenses issued to him. Each licensing application is reviewed individually on its own merit.

Dr. Sato moved to approve the application for a License by Endorsement for Dr. Nilson Ribas. Motion was seconded by Ms. Meyer. Motion approved unanimously.

Dr. Ribas will have to surrender the temporary permit license when the endorsement license is issued.

<u>Miscellaneous</u>

The veterinary technician applications do not indicate refunding of fees. The veterinary applications do indicate there is no refund of fees. The Board agreed to not refund fees to veterinary technicians. No refund of fees will be included on all applications for veterinary technicians effective May 29, 2025.

Rulemaking/House/Senate Files

Mr. Larson stated the legislature passed Senate File 632 which is the Iowa Department of Agriculture and Land Stewardship bill. The civil penalty for the Iowa Board of Veterinary Medicine will be increased to \$10,000. The Iowa Veterinary Technician State Examination will be reviewed for any changes made in Chapter 169.

Dr. Sato moved to go into the Closed Meeting Session pursuant to Iowa code section 21.5(1)(a) to review complaint files where investigative information required by section 272C.6(4) to be kept confidential and 21.5(1)(d) to discuss whether to initiate licensee

disciplinary investigation or proceedings. Motion was seconded by Ms. Meyer. Motion approved unanimously.
