## NEW WORLD SCREWORM UPDATE

The battle to stop the northern march of New World Screwworm continues. Stopping the spread will require ongoing vigilance by all of us. Please report any suspicious findings to your IDALS District Veterinarian or the State Veterinarian's Office at 515-281-5305.

Animals infested with NWS may display the following clinical signs:

- Irritated behavior
- Head shaking
- Smell of decay
- Presence of larvae in open wounds

USDA has made available electronic identification (EID) 840 ear tags for the identification of swine. The tags are available for sow and exhibition swine producers. ## PREMISES IDENTIFICATION NUMBER (PINS)

PINs assign a unique identification number to sites where livestock are housed and aid in disease response and producer outreach. Veterinarians can encourage producers to obtain Premises Identification Numbers (PIN) for their sites. You can find an [informational flyer](#) and [application](#) on IDALS website. Under Iowa law, IDALS can keep information associated with a PIN confidential.
