Electronic Certificates of Veterinary Inspection (eCVI)

Incorporating the use of eCVI's will:

- 1. Save time, improve efficiency, and decrease mistakes.
- 2. eCVI copies are automatically forwarded to both shipping and receiving state animal health offices, saving postage, and providing near instantaneous traceability.
- 3. ID numbers can be transferred into the certificates to reduce time and transposition errors related to writing each official ID number onto a form.
- 4. The electronic forms are legible, making them more accurate.

The eCVI's that are recognized by IDALS are listed below with a brief description:

Veterinary Services Process Streamlining (VSPS)

The U.S. Department of Agriculture offers a web-based system that requires internet connectivity to fill out and submit certificates. This system requires log-in but is free of charge. This system can only be used for large animals. Global VetLINK (GVL)

GVL's electronic CVI is an online, fee-based service that requires access to the internet to create, manage, and submit CVIs for large and small animals.

GVL also offers:

- Coggins (EIA) certificates (EquusLINK)
- Storage and retrieval of lab results (LabLINK)
- Veterinary Feed Directives (eVFDs)
- Certificate retrieval for clients through MyVetLINK.com

VetSentry

Is a fee-based service that allows veterinarians to fill out and issue eCVI's for livestock and small animals using a computer or mobile device. Easy to use, easy to read, and fully searchable PDF format that can be used in the field or office. Can import data from an external source or RFID filled spreadsheets for 100's of animals. Coggin's (EIA) certificates are available.

Free mobile application that allows veterinarians in participating states to fill out and issue eCVI's for livestock. The app instantly generates a secure eCVI and uploads to the state agency.
