

ANTIFREEZE REGISTRATION

Code 208A.4 & 208A.5

The antifreeze registration requirements are as follows:

1. Either the manufacturer, packer, seller or distributor may be responsible for the registration.
2. The registration is permanent. If there is a change in the label or formulation, then a new registration and a new gallon of antifreeze is required.
3. Each brand of antifreeze must be registered. The registration fee is \$20.00 for each brand submitted. Please make check payable to the Iowa Department of Agriculture.
4. An application, along with the current label, must be submitted for each brand of antifreeze. If the product passes testing, then a certificate to permit the sale of that product in Iowa will be issued.
5. The application is to be signed before a notary public.
6. We request that you submit a one-gallon sample and the current label to be used on the antifreeze.
