Dr. Sato moved to approve the updated agenda adding item 8a for the January 25, 2024, Board Meeting. Motion was seconded by Dr. Shuey. Motion approved unanimously.

Dr. Kaisand reported Dr. Troy Brick, Assistant State Veterinarian left Iowa Department of Agriculture and Land Stewardship for a different position. The Assistant State Veterinarian position is open and will be filled.

The Pork Producers presented Dr. Kaisand with an Honorary Pork Producer Award at the Pork Congress this past week. The Board Members and staff extended their congratulations to Dr. Kaisand.

Veterinary License/Veterinary Technician Registration Application(s)

Dr. Lais Dalri Tonn applied for an In-State Temporary Permit where she would be working for Dr. Charles Abraham at his equine clinic. Dr. Kaisand explained the continuing education submitted has not been verified as RACE approved and the documents have not been submitted to the lowa Board of Veterinary Medicine for review and approval. The anticipated start date is March 2024. Dr. Shuey moved to approve the In-State Temporary Permit for Dr. Lais Dalri Tonn. Motion was seconded by Mr. Yoder. Motion approved unanimously.

<u>Miscellaneous</u>

The lowa Board of Veterinary Medicine Examination Proctor Services Agreement was discussed because of the change of the testing vendor. The American Association of Veterinary State Boards included testing sites outside of Iowa for individuals that do not live in Iowa but may work in Iowa. There are new testing sites in Iowa as well. Dr. Kaisand pointed out the current process is providing the testing candidate with the actual score and the new agreement will provide a pass/fail notice to the testing candidate. This information is being provided so the Board has an understanding that in a final review of the examination the testing candidate did not attempt to cheat on the examination. The American Association of Veterinary State Boards makes sure the test vendor is conducting the examination as contracted. The testing centers are subcontracted with the American Association of Veterinary State Boards. The testing centers provide their personnel to proctor the examinations. Ms. Meyer moved to approve the amended Iowa Board of Veterinary Medicine Examination Proctor Services Agreement from January 25, 2024, through October 4, 2024. Motion was seconded by Dr. Sato. Motion approved unanimously.

Veterinary Technician National Examination testing window November 15-30, 2023. This is informational only and no action required.

Rulemaking/House/Senate Files

The proposed Administrative Rules were published in the bulletin on January 24, 2024. There will be a public hearing on February 29, 2024, during the Iowa Board of Veterinary Medicine Board Meeting.

Mr. Larson Reported the Boards and Commissions Bill regarding the final version of the reorganization has not been released. The only information the Board has is there will be a farmer engaged in livestock as a public member of the Iowa Board of Veterinary Medicine.

Mr. Larson reported language has been provided and agreed by Iowa State University for the certification of competency of the Fourth Year Veterinary Student.

Dr. Shuey moved to go into the Closed Meeting Session pursuant to Iowa code section 21.5(1)(a) to review complaint files where investigative information required by section 272C.6(4) to be kept confidential and 21.5(1)(d) to discuss whether to initiate licensee disciplinary investigation or proceedings. Motion seconded by Dr. Sato.
