Warehouse claims W-1 through W-23 and W-25 through W-28 were all recommended by the Bureau for payment, and all were approved by the board. One claim, W-24 was recommended by the Bureau to be rejected by the board due to the claimant request to disregard for small value (\$0.13). This claim was denied payment by the vote of the board.

Mr. Kennedy then informed the board of remaining process of sending out notification to the claimants, receiving the required documents from the claimants (subrogation and assignment form, creditor release, and W-9 vendor forms), and then requesting payment from the Treasurer's office.

There was no further business to come before the board. The chairperson asked for a motion to adjourn. Mr. Behrends made a motion to adjourn. Ms. Shelman seconded the motion, and the board approved the motion unanimously. The meeting adjourned at 11:07 A.M.
