

NOTICE-TO-BIDDERS

BV933619D Nutrient Reduction Wetland Project Section 19, Township 93 North, Range 36 West Buena Vista County, Iowa

Sealed bids will be received by the Iowa Department of Agriculture & Land Stewardship, Division of Soil Conservation and Water Quality (Division), 502 East 9th Street, Des Moines, Iowa, 50319, until 2:00 PM local time, on Wednesday, March 17, 2021, and opened at a public teleconference meeting and read aloud at 2:30:00 PM on the date last mentioned (Call-in number: (866) 685-1580, Access Code: 5152815851). Bids must be submitted on the appropriate bid forms provided and shall include a bid bond in the amount of ten percent (10%). Bidders must also be registered with the Iowa Division of Labor.

In general, the work involves, but is not limited to, selective clearing, excavation, grading, steel sheet pile weir construction, tile installation, CMP water control structure, and seeding. This project includes around 19,536 cubic yards of earthwork, 2,271 square feet of sheet pile, 760 linear feet of RCP tile installation, 710 tons of riprap and, 106 cubic yards of grout, and 24 acres of seeding. The estimated construction cost range for this project is \$300,000 to \$350,000.

A pre-bid conference will be held via video conference at 2:00 PM, on February 25, 2021. The Plans and Construction Specifications governing the construction of the proposed improvements have been prepared by Dallas Heikens, P.E., Jacobson-Westergard & Associates, Inc., and are hereby made a part of this notice by reference and the proposed contract shall be executed in compliance therewith. Copies of the Contract Documents, including Plans, Construction Specifications, and Bid Package, are only available through the website link - <https://iowaagriculture.gov/dscwq/requests-proposals>. Bidders who attend and sign-in to the pre-bid conference will be added to the plan holders list. Printed copies of specifications and plans will be provided to the successful bidder.

The successful bidder shall be required to furnish a Performance/Payment Bond in an amount equal to one hundred percent (100%) of the contract price.
