Field Services – Myers

Myers highlighted the following topics in his report;

- The IFIP program is going strong with 35 districts receiving a total of \$2,970,751.30
- 12 lakes were designated POLs for the SFY22
- 37 SWCDs have been approved for 780 hr contract positions

- The Brian Wilson AML project has been approved for an extension through spring 2022
- Re-authorization for the AML program has yet to be approved by congress
- KCCI Aired a news piece on the AML program on September 29th
