

Water Resources Coordinating Council December 12, 2017

MEETING NOTES

Welcome & Call to Order

The meeting was called to order at 1:30 PM. Copies of sign-in sheets showing member and public attendance are attached.

WRCC Member Agency Updates

EPA (Tate)- Recently held meeting of regional point source providers including discussion of nutrient reduction strategies. Noted that Iowa is ahead of the curve on this and EPA will use IA approach to permitting with other states, especially in small communities. Karen Fluornoy is still tentatively planning to retire in December but is still helping with transition under new regional administrator (Jim Gulliford).

DNR (Schnieders)- Participated in ACWA workshop in Idaho this fall. Point source permitting for nutrient reduction in Hypoxia Task Force states is being adopted in different parts of the country as well. Looking to meet with point source stakeholders this winter in advance of year 5 under permitting for NRS. Permits issued continue to climb slowly. New permits will result in more monitoring data. DNR is using an intern to evaluate 1980-96 baseline data to re-evaluate percentage contribution of nutrient loading from point sources.

Nutrient Reduction Exchange (Iowa League of Cities project) will be able to use RIBITS system in a pilot initiative in order to determine nutrient reduction credit markets. Also looking at Nutrient Reduction Tracker through Walton Family Foundation as a means of measuring nutrient reduction. In 2017, a statewide nitrogen load estimate was modeled and will be included in the Annual Report.

ISU Extension (Benning)- Leadership changes at ISU- Wendy Wintersteen is now president of ISU and Joe Colletti is the interim CALS dean. NRS Annual Report was published yesterday. Copies of the executive summary were available to attendees of the meeting and the full report is on the NRS website.

Dr. Helmers is reviewing effectiveness of NRS practices and expects to be able to update the percentage reductions associated with types of practices, along with scenarios needed to achieve NRS goals.

ICM conference was held this fall. 11 sessions dealt with conservation/soil and water quality. The Agronomy Soil Testing Lab at ISU will be closing at the end of the year to the public. The Lab will only be used internally in the Department.

IDPH (Schmitz)- Deferred to presentation.

UNI (Clayton)- No report.

HSEMD (Benson)- HUD Iowa Watershed Approach partner meeting is Thursday in Des Moines. Partner match is up to \$106 million. A new project website has been launched as well.

HSEMD is working to integrate watershed plans with hazard mitigation plans at county level. Also working with Iowa Flood Center to develop parcel level inundation estimates.

Iowa Flood Mitigation Program is about half expended (\$658 million of \$1.3 billion). Annual report will be issued by January 15 on the HSEMD website. Adkins suggested using the WRCC as a means to increase awareness on flood risk to the general public and asked about establishing more detailed planning at the Council level to get the word out.

Iowa DOT (Nicholson)- ISU and IDOT are partnering on Asset Management and Extreme Weather Events proxy indicators. Iowa Highway Research Board is funding a study on this. Report will be DOT focused but should have relevance for other agencies.

DOT is implementing Federal Aid Swap in which federally funded projects can be swapped for state funds. This will reduce federal compliance requirements for local projects and free up federal dollars for more large projects. The swap impacts about \$150 million in projects underway or in planning. DOT has convened a committee as a part of this to look at environmental changes/impacts as a result of reduced compliance requirements.

USACE (Thostenson)- Updating regulation manual for Lake Red Rock and Saylorville Reservoir. Manual provides water level management guidance for large USACE lakes. Also working with The Nature Conservancy on Sustainable Rivers program, aimed at looking at other impacts/opportunities that can be achieved with different water level management strategies. A component of the modeling has been use of ACPF tools to look at subwatershed impacts and potential conservation practice siting.

Lake Red Rock is under a deviation to maintain the fall raise of 2 feet until March 1 (normally in December) in order to potentially avoid adverse downstream wildlife impacts. USACE is also looking at water quality and wildlife impacts of changes to water level management.

FSA (Goettsch)- New state FSA director had a baby boy yesterday and will be out for several weeks. State has 1.75 million acres in CRP currently (3rd most) and 109,000 contracts, by far the most of any state. Iowa's CRP is predominantly in small site contracts. Continuous signups are not open but FSA is taking receipts for service as they determine what acres are available for 2018.

NRCS (Adkins)- Recent guidance out on ephemeral gully control and repair- "Fix it, Don't Disk It" campaign is out to improve dealing with gullies as part of conservation compliance. Also receiving some funds under PL-566 program for the first time in several years. Will do some projects in Ringgold County and working with partners to scale up new structures and O&M on older sites. NRCS has re-labeled Conservation Collaboration Grant program as Iowa Partners for Conservation. The funding announcement is open now through January 31, 2018.

Working with The Nature Conservancy on a 4RPlus campaign in partnership with CF Industries. Many other partners are involved and emphasis is on business side and investment in soil for long-term profitability.

USGS (Kalkhoff)- Drought conditions are persisting in south central and northwest Iowa, although severity is not as bad as earlier in 2017. Result has been reduced streamflows and reduction in groundwater aquifer levels, impacting private and municipal wells.

USGS is in process of removing 12 nitrate sensors for the winter. All but one sensor is showing nitrate levels in 3-5 range. Also working on study to look at turbidity as a surrogate indicator of phosphorus.

Gillespie asked about drought conditions and absence of burning bans, especially as it pertains to CRP management in sensitive areas.

IEDA (Geerts)- Water and Sewer Fund applications have received 23 applications and made 11 awards in last two quarters. Also incorporating Green Streets criteria into Stormwater projects and providing some design assistance.

IDALS (Gillespie)- WQI statewide program has been largely deployed. Cover crops are still being planted. Signage is going up with cover crops as well.

IDALS is working with RMA on pilot program to buy down crop insurance premiums at \$5 per acre on acres that don't receive any other assistance.

Urban conservation demo project pre-applications have been received. We received 32 applications requesting more than \$3 million with \$18 million in partner investment. Full applications will be solicited in January and new projects will begin in April. Annual reviews are also underway on open projects.

Runoff Risk Decision Support Tool Overview

Dustin Goering, North Central Regional NOAA office, gave a presentation on the Runoff Risk Decision Support Tool that has been developed and deployed in Minnesota and Wisconsin. A copy of that presentation is available on the WRCC website.

Microcystin/HAB Report

Stu Schmitz, Iowa Dept of Public Health and Roger Bruner, Iowa DNR, gave a presentation on Microcystin levels and HABs in Iowa. Additionally, Dr. Grace Wilkinson with Iowa State University, gave a presentation on HAB research. Copies of those presentations can be found on the WRCC website.

WPAC Update

Ann Robinson, WPAC Vice Chair, provided an update on the WPAC. The WPAC met on October 31 and discussed the Annual Report and Areas of Agreement. Due to a change in staffing by the Chair agency, the Annual Report will be submitted to the Legislature in December and posted to the WPAC website.

HUD Iowa Watershed Approach Update

Allen Bonini, Iowa DNR, provided an update on the HUD Iowa Watershed Approach project. A meeting of the project partners will be held on December 14 in Des Moines. All of the project WMAs are now established and some are now procuring engineers and working on landowner outreach. Others are working on watershed plan development and public outreach. The project partners are also working to normalize GIS input for collection of data on practices.
