#### Iowa's E15 Access Standard

- In 2022, the Iowa Legislature passed the E15 Access Standard to ensure E15 is readily available to drivers at convenience stores and fuel retailers around the state.








#### Iowa's E15 Access Standard


# **Make plans now** to bring your retail location into compliance with the E15 Access Standard





## **Implementation Resources**

- State and federal cost-share programs
- Renewable Fuels Infrastructure Program (RFIP) – state funds to install, replace or convert fuel infrastructure to support E15
- About \$20 million available

# **Waivers and Exemptions**

- **Class 1 waiver** Incompatible fuel storage tanks (based on age and material)
- Class 2 waiver Cost to make fuel infrastructure compatible with E15 exceeds \$107,142
- Small retailer exemption On average, sells less than 300,000 gallons of gasoline per year (benchmark years 2020-2022)





# **Regulatory Enforcement**

The Iowa Legislature has authorized the Department to issue a civil penalty of **\$1,000 per day** to non-compliant, non-exempt fuel retailers beginning January 1, 2026.

Fuel licenses can also be suspended or revoked.
